A Settlement has been reached in a class action lawsuit for money damages from Kelly. Plaintiffs claim that Kelly failed to make disclosures in the manner required by the Fair Credit Reporting Act before obtaining background checks on employees and applicants. Kelly vigorously denies that it violated any law, but has agreed to the Settlement to avoid the uncertainties and expenses associated with continuing the Litigation. This Notice summarizes the proposed Settlement. For the precise terms and conditions of the Settlement, review the Settlement Agreement, available at www.hillsonfcrasettlement.com.

Am I a Class Member? Kelly's records indicate you are a Class Member. The class is comprised of two groups: favorable and other than favorable. Kelly's records also indicate that one or more of the background checks obtained on you had a result other than favorable. If you have questions about whether you are in the Class, call 1-888-221-9824.

What Can I Get? If the Settlement is approved by the Court and you submit a Claim Form within the deadline, you will receive a settlement payment. The amount of your payment will depend on the total number of Claim Forms filed, and the amount of attorneys' fees, Class Representative awards, and administration costs approved by the Court. The total settlement fund is \$6,749,000, with up to 1/3 of that fund, \$2,249,666.67, to be used to pay Class Counsel. Class Counsel estimates that those who return the attached Claim Form will receive approximately \$272, although this number will vary depending on the amount of attorneys' fees, Class Representative awards, administration costs, and the number of Claim Forms submitted. 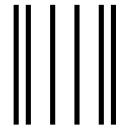
How Do I Get a Payment? You must submit a timely and properly completed Claim Form postmarked no later than **April 25, 2017**. If you complete the Claim Form and receive a payment, you will lose your right to sue Kelly for claims that were or could have been brought in this lawsuit and that relate directly or indirectly to Kelly obtaining a background check on you. You may use the Claim Form attached to this Notice or complete one online at www.hillsonfcrasettlement.com.

What Are My Other Options? (1) **Do Nothing**. If you do nothing in response to this notice, you will receive no monetary recovery and will lose both your right to sue Kelly over matters related to this suit in the future and to object to the settlement of this suit. (2) **Exclude Yourself**. You may exclude yourself from the Settlement Class by mailing a written notice to the Settlement Administrator by **April 10, 2017**. If you exclude yourself, you cannot receive a settlement payment, but you keep any rights you may have to sue Kelly over the legal issues in this Litigation. Exclusion instructions at www.hillsonfcrasettlement.com. (3) **Object**. If you do not exclude yourself, you and/or your lawyer have the right to appear before the Court and/or object to the Settlement. Your written objection must be filed with the Court no later than **April 10, 2017**. Objection instructions at www.hillsonfcrasettlement.com.

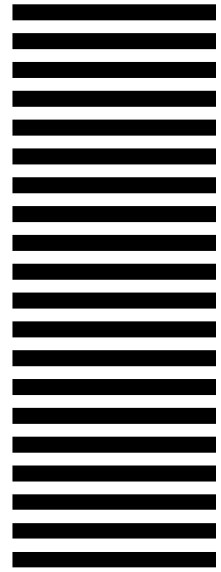
Who Represents Me? The Court has appointed a team of lawyers from Nichols Kaster, PLLP, Berger & Montague, P.C., and Lyngklip & Associates to serve as Class Counsel. You may hire your own lawyer at your expense if you so choose.

When Will the Court Consider the Settlement? The Court will hold a final approval hearing on **August 2, 2017 at 10:00 a.m.** at 231 W Lafayette Blvd., Detroit, MI 48226. At that hearing, the Court will hear any objections concerning the fairness of the Settlement, decide whether to approve the requested attorneys' fees, Class Representative awards, and administration costs, and determine the final fairness of the Settlement.
